- 2. At Fall Board Meeting in St. Louis, Missouri, September 2019

The Executive Committee has met nine (9) additional times to take action in place of the Board.

Report on Bylaw Amendments adopted by Mail Ballot

AMENDMENTS: 2/3 of votes cast: 119 votes cast or 80; 121 votes cast or 81; 122 votes cast or 82; 123 votes cast or 82.

2. Shall the bylaw amendment to allow the Recording Secretary to serve more than one but no more than five terms like the Treasurer be adopted?

9. Shall the rotation continue forward if a State Garden Club passes its turn on the Nominating Committee.

Votes cast: 122 In favor: 114 Opposed: 2 Illegal votes: 6

## AMENDMENT ADOPTED

10. In the event of a National Emergency, shall use of an Internet service that supports anonymous voting be permitted for the receiving of election ballots within 30 days by the Recording Secretary?

Votes cast: 123 In favor: 114 Opposed: 3 Illegal votes: 6

# AMENDMENT ADOPTED

11. Shall the NGC Board of Directors be required to approve the holding of a virtual NGC Annual Convention the same as is required to approve the time and location of an in-person Convention?

Votes cast: 122 In favor: 107 Opposed: 9 Illegal votes: 6

## AMMENDMENT ADOPTED

12. Shall meetings of the Board of Directors, the Permanent Home and Endowment Trustees, all Committees and the NGC Membership be permitted to be conducted by telephone and/or through use of Internet meeting services designated by the President or the Chairman calling the meeting?

Votes cast: 123 In favor: 115 Opposed: 2 Illegal votes: 6

13. Shall the requirement that Fall Board Meeting be in St. Louis in the election year be removed from the bylaws to allow for more flexible scheduling of Fall Board Meetings?

Votes cast: 123 In favor: 102 Opposed: 15 Illegal votes: 6

#### AMENDMENT ADOPTED

14. Shall the requirement that Fall Board Meeting (FBM) be held in a member State Garden Club in even-numbered years be removed from the bylaws to make scheduling of FBMs more flexible?

Votes cast: 122 In favor: 103 Opposed: 13 Illegal votes: 6

## AMENDMENT ADOPTED

15. Shall State Presidents also be permitted to serve on the Board of Directors as Chairmen or Vice-Chairmen of future NGC Conventions or Fall Board Meetings?

Votes cast: 122 In favor: 111 Opposed: 5 Illegal votes: 6

# AMENDMENT ADOPTED

16. Shall State Presidents also be permitted to serve as a Committee Chairman or Vice-Chairman on a NGC Standing Committee?

Votes cast: 119 In favor: 77 Opposed: 36 Illegal votes: 6

#### AMENDMENT DEFEATED

17. Shall an Engagement Letter be obtained by the Internal Audit Committee for the independent auditor selected by the NGC (Internal) Audit Committee?

Votes cast: 121 In favor: 114 Opposed: 1 Illegal votes: 6

18. Shall reference to subscriptions of The National Gardener be removed from the bylaws since The National Gardener is no longer subscribed?

Votes cast: 123 In favor: 117 Opposed: 0 Illegal votes: 6

#### AMENDMENT ADOPTED

19. Shall reference to printing and mailing of The National Gardener be removed from the bylaws since The National Gardener is no longer printed or mailed?

Votes cast: 123 In favor: 117 Opposed: 0 Illegal votes: 6

#### AMENDMENT ADOPTED

20. Shall reference to NGC Life Membership contributions as a source of funding for the NGC Scholarship Fund be deleted from NGC bylaws since the Scholarship Fund no longer receives funding from Life Memberships? (Proposal #9)

Votes cast: 122 In favor: 116 Opposed: 0 Illegal votes: 6

#### AMENDMENT ADOPTED

21. Shall amendment of NGC bylaws be authorized to be conducted electronically as well as by postal mail ballot in the event a National Emergency causes the cancellation of a NGC convention?

Report on Election of Officers for 2021-2023 Administration by Mail Ballot The President called on the Recording Secretary to read the Bylaws pertinent to the Election of Officers:

# ARTICLE XI - ELECTION OF OFFICERS Section 1. - ELECTIONS

E. In the event a National emergency prevents elections held at a NGC Convention, elections may be held by mail.

- 1. Ballots shall be sent by electronic device or postal mail to the Board of Directors by Headquarters.
- 2. All ballots must be received by the Recording Secretary within thirty (30) days by postal mail to be counted.
- 3. A plurality of the ballots returned shall determine the results.
